Activity update Public engagement

Following the launch of a public consultation on a Scottish deposit return scheme in June, Zero Waste Scotland – acting on behalf of the Scottish Government – will have a presence at a range of events and locations over the summer to raise awareness of Scotland's commitment to a national deposit return scheme, hear views, and encourage as many people as possible to have their say.

Live webinar

For those who can't make it along to one of the public engagement events across Scotland, a live webinar will be held on 27 August. The hour-long webinar will be broadcast at http://zerowastescotland.org.uk/DRS-live and on Facebook Live from 1pm.

Hosted by freelance journalist Hayley Matthews and featuring Zero Waste Scotland speakers, the webinar will give people a clear, engaging presentation on what a deposit return scheme is; inform how their views can help shape what type of scheme could work best for Scotland; and provide an opportunity to ask questions directly to the panel.

The webinar will outline the 12 main factors which need to be considered when designing a deposit return scheme – including how much the deposit should be, where containers can be returned, and who will manage the scheme.

It will also talk through four hypothetical examples that have been created by Zero Waste Scotland to help people understand how different factors of a deposit return scheme could vary, creating different scheme designs with different outcomes for Scotland.

There will be an opportunity for stakeholders and members of the public to submit their questions to the panel via our **online form** or on social media, using the hashtag #DepositReturn, before the event – or live via social media during the webinar. During Zero Waste Scotland's work to consider how a deposit return scheme could work best for Scotland, we have heard from hundreds of partners keen to find out more, share their thoughts and explore potential challenges.

In addition to collating views from more than 120 one to one interviews and strategic conversations, Zero Waste Scotland has approached businesses operating and facilitating deposit return schemes overseas to share the value of their experience with the Scottish public.

Opinion pieces from **Lithuanian operator USAD** and Swedish operator **Returpack** have now appeared in the Scottish media, with a third from waste management company REMONDIS, which is involved in a German deposit return scheme, expected to be published shortly. All three will be published as case studies on the Zero Waste Scotland website in the coming weeks.
